<b>Representation</b>	It is expected that students who are selected for representative teams will fulfil their commitments to play in subsequent games with the team.
<b>Special requirements</b>	For all sports, students are to wear full school sports uniform. Students in football will need football boots, shin pads and a mouthguard. Students in rugby league will need football boots and a mouthguard. Headgear is strongly recommended.  Students will need to wear sunscreen and have a hat whilst they are not playing.  Students will need all of their food and drink for the day as there will be NO canteen available.
